Conferences: Weekly

- Echocardiography: The full curriculum of echocardiography is reviewed annually. *Drs. Smith, Romero, & Rubenson.*
- Case Conference: Challenging cases are presented to the faculty. Review and debate over the differential, review of the imaging workup, and discussion about novel or investigative therapies. *Drs. Patel and Suhar.*
- EP Conference: The conference is weekly and is divided into 4 elements each month
 - The fellows teach the residents how to read ECGs.
 - The fellows teach the residents Cardiology for the IM Boards
 - Challenging EP case are presented.
 - EP Lecture topics. *Drs. Gibson, Curtis (Emeritus), and Patel.*
- Pacemaker and Defibrillator Hands-On Interrogation Course: 5 weekly conferences are hosted which includes didactic reviews of device programmers, troubleshooting, as well as weekly hands-on management of device settings and rhythm management on device interrogators. *Drs. Cork, Gibson, Olson, Rogers and Patel.*

- Journal Club – Review of a recent article with attention paid to the research protocols and methodology of the study.
 - In addition, once a month this is replaced by a lecture series given by researchers at Scripps Research which covers research related topics: Statistics, study design, grant writing, etc. *Dr. Muse.*
- Cath Conference – Although this is for the fellows on their cath month, most fellows attend due to the educational value. *Dr. Stinis.*
- Lecture Series. Each attending in the division participates in the lecture series which covers a large range of fundamental topics, guideline and board directed lectures, novel therapies, and device development. This year, we have been replacing some of our internal lectures with external speakers. Eventually, the plan is to have a topic covered by an internal and then an external speaker every other year. We are recruiting some of the best speakers in the country to provide our fellows with their talks. *Every faculty member*
- This year, we are replacing some of our faculty with outside speakers. The plan is to offer each topic with our faculty member one year and an outside speaker the next year.
